

John G. Looney, MD, MBA

FACULTY PROFILE

Dr. Looney is a Professor of Psychiatry at Duke University. His professorship has been funded by the Cotswold Foundation of Philadelphia.

He was recruited to Duke in 1986 from Timberlawn Hospital and The University of Texas, Southwestern Medical School. At Timberlawn Hospital he specialized in intensive treatment of severely troubled children and adolescents. These patients had experienced multiple failures of prior outpatient and hospital treatment. Through the American Psychiatric Association, he published treatment methods for these children and adolescents. He described methods that might bring back into health those children and adolescents who have suffered serious and longstanding problems. His book, Chronic Mental Illness in Children and Adolescents details this treatment focus.

After his medical training at Dartmouth, Southwestern, and the University of Michigan, Dr. Looney served in the United States Navy. During the Vietnam War era Dr. Looney served as a research psychiatrist at the Navy Medical Neuropsychiatric Research Center. He headed the Health Care Systems Branch which designed the first service-wide research health database. He also headed the Psychiatric Effectiveness Branch which studied optimal functioning in special populations such as Navy SEALs, naval aviators, marine drill instructors and returning prisoner of war officers.

He was then a Research Associate at the Timberlawn Psychiatric Foundation where he focused on research methods of understanding interactions within families associated with healthy, versus troubled, development of children. He assessed family functioning in families of different ethnic groups, and this work is detailed in the book The Long Struggle co-authored with Dr. Jerry M. Lewis.

Dr. Looney was recruited to Duke in 1986 as Director of the Division of Child and Adolescent Psychiatry. He was charged with reorganizing the Division, with an emphasis on developing a full continuum of psychiatric services as well as adding programs to treat young people with drug and alcohol problems. He was also charged with increasing the amount of research in child and adolescent psychiatry through the recruitment of established researchers as well as younger ones with promise. He provided the supportive environment necessary for these researchers to be productive and for them, in turn, to recruit additional researchers. Research funding increased from zero external funding in 1986 to an accumulated amount of over one hundred and sixty million dollars (\$164,107,130). Dr. Looney is now a member of the Duke Institutional Review Board. He enjoys explaining to medical and surgical colleagues about research matters in child and adolescent psychiatry as the research portfolio continues to build.

Dr. Looney has developed innovative approaches to dealing with the problem of binge drinking by college students. He leads teams of consultants to campuses to design methods of institutional cultural shift from laissez faire administration of student affairs to more active involvement in student life by college and university faculty and administrators. Within Duke, Dr. Looney has been the Director of the clinical program for substance abusing youth (See <http://aiopduke.wordpress.com>). Currently he is the Senior Consultant to the Duke Consortium for the Study of the American College Student, a program he developed. This program provides teaching, clinical consultation and research about healthy versus troubled adaptation to college. This program contains the largest survey database in the world about college students.

He has consulted to a large number of agencies outside of Duke including: Durham Public Schools, Volunteer Behavioral Health of Tennessee, Carolina's Medical Center and multiple law firms. Currently he consults to governmental agencies on the Cumberland Plateau in Tennessee about a system of care for children whose parents are in prison for methamphetamine, and he consults to rural, public sector agencies serving adolescents in North Carolina.

Dr. Looney is Board Certified in an unusually broad array of skills and knowledge. He uses these varied skills in forensic consultations, the above-mentioned activities, and in the treatment of private patients in the Private Diagnostic Clinic of Duke Medical Center. He organized thirty faculty members into the Duke Forensic Psychiatry Associates. This group prides itself on being able to respond to the needs of legal professionals rapidly, and the group calls itself the Forensic SWAT Team. He now serves as a Senior Consultant to this program.

He is the author of numerous journal articles and book chapters. He is the author, editor or coeditor of multiple books and monographs including twelve volumes of Adolescent Psychiatry. He is a Fellow of some of the most prestigious honorary organizations in psychiatry including the American College of Psychiatrists, the Group for the Advancement of Psychiatry (GAP), and the Benjamin Rush Society. He serves on the governing boards of the latter two, recently advancing to President-Elect of GAP. He also serves as Vice President of the Southern Psychiatric Association. He was recently honored when a benefactor asked that his name be used for a new endowment to pay for the treatment of adolescents with substance abuse disorders who cannot otherwise pay. The program is entitled the John G. Looney, MD Endowment. He has recently also been honored with a Fellowship in his name in the Group for the Advancement of Psychiatry, the Cotswold/Looney Fellowship.

Dr. and Mrs. Looney have raised three sons, now married, who have excelled in academics and athletics, two of whom are physicians (orthopaedic surgery and interventional radiology). One manages the Looney family's ranching operation.

SENIOR CONSULTANT AND PRIOR DIRECTOR, DUKE CONSORTIUM FOR THE STUDY OF THE COLLEGE STUDENT

Dr. Looney directs this clinical, educational and research program investigating differences between healthy and troubled adaptation to college. This program contains the world's largest survey research database about college students.

PSYCHOTHERAPY AND PHARMACOLOGICAL MANAGEMENT

Dr. Looney sees private patients. He provides treatment for patients with a wide variety of disorders. He treats children, adolescents and adults.

CONSULTANT TO VOLUNTEER BEHAVIORIAL HEALTH OF TENNESSEE

Dr. Looney assists this community mental health system that serves over twenty counties in the more rural areas of central and eastern Tennessee. A methamphetamine epidemic in this Appalachian culture created severe problems for children and adolescents whose parents are addicts. Telemedicine is used to cover an extensive geographic area.

COMPLETED PROFESSIONAL ACTIVITIES

DIRECTOR, DUKE SUBSTANCE ABUSE TREATMENT PROGRAM FOR YOUTH

Dr. Looney served as the Director for the Duke Substance Abuse Treatment Program for Youth. He developed in 1986 a very active treatment and research program for adolescents from regional high schools and for college students at Duke and other universities. This entity continues as a model program. It was the first such program in a Division of Child and Adolescent Psychiatry in an academic medical center in America.

DIRECTOR, CAMPUS ALCOHOL INITIATIVE

This position was a joint one between Duke University Medical Center and The North Carolina Governor's Institute on Alcoholism and Substance Abuse. The position was funded jointly by a private philanthropist and the federal government (National Institute on Alcohol Abuse and Alcoholism). The Campus Alcohol Initiative (CAI) provided consultation to colleges and universities about methods of reducing binge drinking by undergraduates. The CAI has carried out research to measure the effectiveness of campus interventions.

ORGANIZATIONAL FINANCIAL OVERSIGHT

Dr. Looney served as Chair of the financial oversight committee of the American Psychiatric Association. This group provides oversight of the investment of the endowment of the APA. Under his leadership the investment policy and practices were reorganized. During his tenure as Chair the amount of managed money doubled to over \$50 million dollars.

SYSTEMS MEDICAL DIRECTOR, PENINSULA BEHAVIORAL HEALTH, KNOXVILLE, TENNESSEE

This large non-profit health system contracted with Duke for Dr. Looney's temporary administrative services. The system is comprised of a 100 bed private psychiatric hospital, a large partial hospital system, two psychiatric units within general hospitals and four outpatient psychiatric clinics. It also includes a 100-bed residential treatment center for adolescents with severe difficulties. Geographically the system covers a large part of East Tennessee. It is the largest integrated behavioral health care system in Tennessee. Dr. Looney had administrative responsibility for all clinical programming and for activities of a medical staff of twenty psychiatrists. Peninsula Behavioral Health has been formed by a merger of four previously independent entities. It was Dr. Looney's responsibility to integrate these different entities into one system. Dr. Looney is trained in business administration and used his training in this development project. This project won the Tennessee Quality Commitment Award (similar to the Malcolm Baldrige national award system). Dr. Looney served as the physician member of the Board of Peninsula Behavioral Health. This organizational program has been completed, and Dr.

Looney now serves as a consultant as needed. The medical staff created an Award of Special Recognition to honor Dr. Looney for building this system.

PSYCHIATRIC CONSULTANT TO SCHOOLS

Dr. Looney was the consultant to Durham Public Schools and nearby public and independent school systems for twenty years. He met regularly with counselors and principals to assist in management of difficult students within the schools or to facilitate referral to outside professionals. This program was a model for a current program now funded by the Duke Endowment.

CONSULTANT TO THE CAROLINA'S MEDICAL CENTER PROVISION OF CLINICAL SERVICES FOR CHILDREN, ADOLESCENTS AND THEIR FAMILIES

The Carolina's Medical Center is the largest provider of psychiatric services in the Carolinas. Dr. Looney consulted there regularly for several years, and now serves as a consultant as needed.
