## MEDICAL RECORD REVIEW INDEPENDENT MEDICAL EXAMINATION

- 1 – review and organization of the records
- 2 – review and interpretation of imaging studies
- 3 – review claimant questionnaire
- 4 – claimant interview
- 5 – claimant examination
- 6 – research relevant to case specific information
- 7 – conversations with requesting party to insure response to important key issues
- 8 – dictation of report and response to specific questions regarding diagnosis and treatment, causation, apportionment, etc.
- 9 – transcription review and editing for final preparation
