Currently, Mr. Pembleton *has over 33 years of experience investigating and reconstructing highway vehicle collisions, and has been directly involved in over 4,200 collision investigations, collision analysis and/or collision reconstructions.* Mr. Pembleton *has received several hundred of hours of formal education and training in highway crash investigation, analysis and reconstruction, as well as hundreds of hours of formal training, education and experience in forensic evidence preservation, documentation and collection.* In addition, he has received hundreds of hours in the fields of forensic and commercial photography and videography, as well as automotive mechanical technology and mechanical engineering technology. Mr. Pembleton *has also conducted hundreds of hours of hands-on research and development of controlled testing in the specific areas of dynamic and static friction/skid testing and crash dynamics, as well as achieving continuing education and training in other associated disciplines.* He *has also provided expert testimony in various courts of law, and has provided sworn testimony at depositions, hearings and arbitrations in hundreds of cases throughout the United States and Central America.*

Mr. Pembleton maintains his expertise in the areas of Multidisciplinary highway crash reconstruction and automotive systems failure analysis, including the ability to download and analyze data from crash data recorders (CDR). This expertise involves ground transportation collision causal factors investigations, contributory factors, vehicle safety standards compliance and performance, as well as automotive technology and systems failure analysis. He actively applies this extensive training and practical experience in collision dynamics, area of impact, vehicle pre-impact, impact and post-impact speed calculations, along with the correlation of the direction of principal force, emphasizing the relative movement and positions of the vehicles. Mr. Pembleton regularly conducts analyses to determine the change in velocity (delta-V), energy dissipation, occupant dynamics and positioning, as well as passive and active occupant restraint system usage/performance. Headlight and taillight examinations are also conducted to determine on/off illumination at impact, trace evidence collection,

referencing pedestrian and occupant points of contact and injury causation and indexing. Mr. Pembleton is also a certified Crash Data Recorder (blackbox) download technician.

In addition, Mr. Pembleton also has extensive training and experience with large trucks (both articulated and non-articulated) and motorcycle dynamics, including railroad grade crossing collisions, and emergency vehicle operations, as well as mechanical systems or component function, failure and performance analysis. He also conducts analyses of roadway geometric design, roadway topography, compliance and performance of traffic safety/control devices, including traffic pattern alterations in construction/work areas, as well as environmental and human factors relating to highway transportation safety for daylight and night time driving and collisions.
