Vehicle Accident Reconstruction

Reconciles witness statements with physical evidence from incidents involving heavy trucks, commercial vehicles, automobiles, motorcycles, bicycles, pedestrians, wildlife and human factors.

Compiles and analyzes data to determine time, speed, and distance relationships. Determines coefficient of friction and drag factors for sliding vehicles. Completes conservation of linear momentum and vehicle dynamics calculations. Conducts vehicle crush energy analyses.

Determines principle direction of forces and critical speed yaw. Verifies speed and dynamics involved in spins and rollover. Calculates airborne and projectile trajectories. Evaluates seatbelt and occupant restraint performance, as well as overall highway safety compliance.

Event Data Recorder (EDR)

Recovery, imaging, and analysis of the retrieved data from crash data collectors “i.e., black boxes” in automobiles, light trucks, and sport utility vehicles (SUVs).

Vehicle Systems

Determines brake effectiveness. Evaluates airbag deployment/nondeployment events. Conducts headlight filament analysis (On/Off determination). Analysis of mechanical component malfunctions and failures related to vehicle accidents.
