She provides expert testimony and deposition services for courts using standardized clinical and forensic testing, symptom validity measures, collateral record review and structured forensic interviews.

Serves as a court-appointed expert witness for multiple California and Nevada counties, including Shasta, Siskiyou, Trinity, Tuolumne, Del Norte, Mendocino, and Glenn. Provides forensic psychological evaluations including Competency to Stand Trial, Insanity, Mental Health Diversion, sex offender assessments, sentencing evaluations, and risk assessments. Completes Acuity Review Reports in correctional settings for the identification and mitigation of clinical risk factors. Holds annual contracts with the Department of Health and Human Services Agency, providing forensic evaluation services for Shasta and Tehama Counties.

Provided competency restoration services for individuals deemed incompetent to stand trial through structured psychoeducational programming in preparation for legal proceedings.

Facilitated crisis stabilization interventions pursuant to Welfare and institutional Code 5150 for individuals experiencing acute psychiatric crises.
