## **Work Experiences**

### **Integrated Medical Center of Corona – Doctor of Chiropractic, 2/2023 to Current**

My job duties include but not limited to performing exams, creating treatment plans, referring and ordering further studies according to patient's need, and adjusting patients with various ailments and injuries. As one of the more seasoned DC, trying to share my knowledge and experience with team of chiropractors and medical assistants and to lead by example.

### **Yi Chiropractic, Inc. – Doctor of Chiropractic, 9/2020 to 2/2023**

Went back to Superior Health Centers and took over the chiropractic practice side of the clinic overseeing all the peripheral neuropathy and radiculopathy patients. This clinic became an integrated practice with a Medical Doctor offering PRP injections, weight loss program, erectile dysfunction treatments, as well as Cool Sculpting. Performed initial exams and evaluations for diagnosis, developed plan of care, and referred patients to our medical doctor as well as directly performing treatments and managing chiropractic assistants.

### **The Joint – Doctor of Chiropractic, 4/2020 to 9/2020**

Worked 4 days a week seeing about 30-40 patients a day. The clinic that I got assigned used to have a main doctor that was there for a long time and had many loyal patients. Once The Joint let him go, there were lots of grumblings and dissatisfactions from patients. I was able to quiet the complaints and win over patients, improving patient relationships with the clinic during the transition. I received many positive reviews from patients. Also achieving about 50-60% conversion rate of new patients converting to recurrent wellness patients.

### **Superior Health Centers Inc. – Doctor of Chiropractic, 9/2015 to 4/2020**

Transitioned back to working as a Doctor of Chiropractic. This clinic was cash practice that offers integrated services of chiropractic and stem cell injections and focused on treating peripheral neuropathy, sciatica, and arthritis issues, using laser, red LED lights, e-stim, decompression, Arthro-stim, and manual therapies. Was in charge of initial evaluation to find the correct diagnosis, developing treatment programs, referrals if needed to, educating and implementing, treating, and overseeing patient care as well as managing chiropractic assistants. Needed to work very closely with other chiropractors, nurse practitioners, and case managers in office. To recruit new patients, I gave presentations for about an hour once or twice a week speaking in front of about 20-30 people each time at dinner seminars. Clinic grossed over \$2 million each of the years that I was working. Furloughed due to COVID.

**Namsan Orphanage in Seoul, South Korea – Volunteer, 7/2013 to 12/2014**

Had a chance to go out to South Korea with my wife, volunteering at the orphanage. Was teaching kids English and helping out with orphanage works. Getting to know kids and helping them was very joyful and blessing time.

**Servus, Inc. – Owner/Operator, 8/2007 to 9/2015**

Shifted to restaurant industry. Started and operated Bento Box Japanese Grill with a business partner. Learned the basics of managing and operating a restaurant. Implemented new menus items and new procedures to effectively manage the restaurant. Was able to grow the business and opened a second restaurant in 2010. Started to work as a consultant to other restaurant owners in 2011. Learned what it was to be a good manager and leader. Gained a valuable insight and lessons as to how to run a business which will help me in any field of work. Currently I am on the Board of the company and not working day to day operation.
