I participate in training and mentoring for Addiction Medicine Fellows from UCSF and UCLA training programs as well as train fellow primary care providers within the CDCR. I am a Fellow with the American Academy of Family Medicine as well as Board Certified in Addiction Medicine by the American Osteopathic Academy of Addiction Medicine.

*October 2014 - August 2022 (retired from active duty September 2021)*

Clinical Director serving high-risk population of approximately 1300 Care Level 2 female inmates in FCI and Federal Prison Camp, supervising clinical performance of one Psychiatrist, Physician, four mid-level providers, supporting clinical and administrative care duties of six nurses. Administered Utilization Review Committee, providing oversight and recommendations for all outside referrals for local care. Performed numerous primary care procedures as well as prenatal obstetrical care. Provided TDY and remote coverage for USP Atwater, FCI Herlong USP Victorville, MDC Los Angeles, FCI Sheridan, FCC Tucson and FCI Mendota during periods of provider absence, garnering two Letters of Commendation. 40+ hours per week + 24 hour on-call coverage

### *Accomplishments:*

- Served as co-chair of the BOP National Transgender Clinical Care Team, tasked with evaluating transgender inmates for surgery and formulating updating national BOP clinical guidance.
- Selected as Clinical Physician of the Year 2020 by the Physician Professional Advisory Committee (PPAC) of the U.S. Public Health Service.
- Immediately embraced new BOP policy for Opioid Use Disorder Treatment, completing training for OUDT X-waiver and selected as National Clinical Consultant for the BOP for OUD treatment. Worked with ACLU and AUSA attorneys to ensure successful transition of first OUDT inmate at FCI Dublin, avoiding costly lawsuits and patient withdrawal. Selected as National Clinical Consultant for OUD treatment, provided direct and tele-health care to five regional institutions, ensuring patients could remain on their treatment during COVID-19 lockdowns.
- From the start of COVID-19 pandemic established rigorous local policy for limiting risk of infection introduction and spread in facility. The only intra-facility outbreak in December 2020 was quickly isolated and controlled via mass testing of inmates as well as recruitment of Alameda County support for staff testing. Appropriated three doses of Regeneron monoclonal antibody cocktail for local administration to high risk inmates which led to net result of hospitalization of only two high-risk inmates and zero deaths.
- Aggressive education of staff and inmates regarding COVID-19 vaccination as well as personal administration of vaccines led to >85% of FCI Dublin staff fully immunized, and >85% of inmates fully immunized, with consistently highest rates in the BOP.
- Volunteered for urgent BOP deployment in support of massive COVID-19 outbreak at FCC Lompoc; assessment of situation led to immediate COVID-19 testing of over 1000 inmates resulting in rapid identification of local crisis of nearly 95% infection prevalence, avoidance of unnecessary inmate movement, and helping to establish sound guidance for quarantine/isolation procedures to avoid further spread of infection. Requested for and responded to similar Fall 2020 outbreak at FCC Tucson, helping with identification of patients to receive Bamlanivimab treatment and education of staff on COVID-19 vaccine acceptance.

- Spearheaded implementation of BOP policy for care of transgender inmates, became regional subject matter expert for transition initiation and care. Initiated female-to-male transition for 10 patients and provided care for over 40 transgender patients in FCI Dublin's population, including both female-to-male as well as post-operative male-to-female patients.
- Volunteered for urgent RedDOG deployment for support of southern border Central American asylum seekers to ensure adequate assessment and triage of migrant families and accompanied children in 2018. Provided invaluable triage, evaluation and treatment and established standards of care for incoming PHS teams and contract providers at Customs and Border Protection stations in Clint and El Paso Texas as well as New Mexico. Assisted CDC efforts in screening all patients and performed Influenza screening for at-risk individuals, reducing risk of transmission among vulnerable migrant population.
- Volunteered for emergent request for deployment to manage acutely decompensating dialysis VI/PR hurricane victims, acted as site lead in charge of over 100 seriously ill patients placed in logistically challenging setting, ensuring they received appropriate emergency treatment, screening for ongoing medical issues, and case management.
