Curriculum Vitae for Edward J. Priz, CPCU, APA

Edward J. Priz is a forensic premium auditor, consultant, author, and expert witness on the subject of commercial insurance cost and coverage, with particular expertise on premium audits for Workers Compensation and other commercial insurance. His expertise includes underwriting, audits, classifications, experience modifiers, premiums, Retrospective Rating, Large Deductible policies, and agent/broker professional standards and duties, and related issues.

He began his insurance career in 1976, starting as a life and health insurance producer. He began working with commercial property and casualty insurance in 1978 as an insurance producer/agent/broker at American Mutual Insurance. His training and experience at American Mutual included working with Retrospective Rating plans for Workers Compensation insurance and other commercial liability insurance. He subsequently worked as an insurance broker for Vanguard Insurance Agency, working with commercial property and liability insurance for Allied Van Lines agents across seven states. In late 1981 he began working with Alper Services, a company that operated a commercial insurance brokerage as well as an insurance consulting company, AuditRate. At Alper he served as an insurance broker and consultant on commercial property and casualty insurance. Priz also underwrote commercial property and casualty insurance while working at Alper. With the AuditRate division he also began consulting on commercial property and casualty insurance, including Workers Compensation insurance premium charges. With AuditRate, he also trained as a premium auditor, working on premium audits for clients of the Alper Agency. He also worked as a consultant on commercial insurance, including Workers Compensation insurance, for Corporate Policyholders Counsel from January, 1987 through October, 1987.

In late 1987 he established his own consulting firm to specialize in consulting on Workers Compensation insurance premiums and audits, as Advanced Insurance Management. Since 1987, at Advanced Insurance Management he has consulted on Workers Compensation insurance audits and premiums as well as on commercial insurance coverage and cost, including General Liability, Commercial Property, Business Auto, and other commercial liability insurance.

Clients of this consulting practice have included manufacturers, contractors, utilities, transportation companies, staffing companies, a federal government agency, a chamber of commerce, and insurance companies and insurance agencies. Some well-known clients have included Caterpillar, Inc., Federal Mogul Corporation, Walsh Construction, Bridgestone/Firestone Tire, and the San Francisco 49ers.

Mr. Priz has also served as a consultant to insurers XL Insurance America, Lloyds of London, Zurich American Insurance, Zenith Insurance, California Insurance Company, Liberty Mutual Insurance, Hartford Insurance, Dakota Truck Underwriters, Diamond Insurance Company, FCCI Insurance, 7710 Insurance, Starnet Insurance Company, and Great American Insurance on issues involving Workers Compensation insurance coverage, premium computation, underwriting, classifications, experience modifiers, Retrospective Rating and Large Deductible policies, and premium audits.

He is the author of *Workers Compensation: A Field Guide for Employers*, published in 2010, as well as *The Ultimate Guide to Workers Compensation*, published in 2005, and *CompControl*, published in 1995 (revised edition 2001).

Mr. Priz has served as an expert regarding commercial property and casualty insurance, with a particular focus on Workers' Compensation insurance premium computation, insurance agent/broker standards of care, and other aspects of commercial property and liability insurance, in cases filed in both federal and state courts and arbitrations in California, Colorado, Connecticut, Delaware,

Florida, Georgia, Illinois, Iowa, Louisiana, Mississippi, Missouri, Nebraska, Nevada, New Jersey, New York, Ohio, South Carolina, Tennessee, Texas, and Virginia.
