Each opinion records the specific markers examined and comparable references consulted, producing a transparent and reproducible basis for the conclusion.

Valuation & Reporting

Comparable-sales analysis drawn from primary auction results (Heritage, Sotheby's, Christie's, Bonhams, Phillips) and recognized secondary-market and licensed databases, with current retail referenced where relevant. Reports state the standard of value, effective date, scope of work, and any extraordinary assumptions or limiting conditions.
