My practice is rooted in a high-acuity Level III perinatal center, where I specialize in caring for patients across the antepartum, labor and delivery, postpartum, and neonatal intensive care continuum. I hold board certification in Neonatal Intensive Care Nursing (RNC-NIC), certification in Electronic Fetal Monitoring (C-EFM), and I am a certified instructor for the Neonatal Resuscitation Program (NRP), reflecting advanced expertise in neonatal stabilization and resuscitation.

My training includes physiologic birth practices, advanced fetal monitoring, and the management of obstetrical emergencies, including interpretation of fetal heart rate tracings, oxytocin administration, management of hemorrhage and hypertensive disorders, and support for both unassisted and operative births.
