Annual and quarterly reviews of agency services are conducted with follow up formal reports to indicate areas in which the agencies need to improve practices and enhance trauma informed engagement with youth. As a way to enhance services, program development strategies and trainings are created and provided to county contracted agencies to ensure practice improvements and ensure appropriate services are being provided to youth with significant mental health acuity and histories of trauma.
