- Customers include the Federal Bureau of Investigation, Internal Revenue Service, Customs and Border Protection, United States Secret Service, United States Navy, numerous local and county law enforcement agencies, and private security firms for protection of facilities such as the Three Mile Island and Diablo Canyon Nuclear Power Plants.
- PolyFrang current offerings includes: 9mm, .223/5.56mm, .308 Win, and .300 AAC Blackout.

- Invented and manufacture the TX-50, auto-indexing, progressive reloading press capable of loading up to .50 BMG. Capable of loading more than 500 rounds per hour, a conversion is available for large rifle primer cartridges.
- Provide educational opportunities on the ammunition manufacturing process and corresponding toolmarks for law enforcement agencies, specifically for their crime lab and firearm unit technical staff. I have provided this training for such agencies as the California Criminalistics Institute (CA-DOJ), Los Angeles Police Department Firearms Unit, Los Angeles County Sheriff's Department Crime Lab, and Orange County Sheriff's Department Crime Lab.

- Honored by the Association of Firearm and Tool Mark Examiners (AFTE) to serve as a Technical Advisor to AFTE members worldwide to assist in the furtherance of the work of law enforcement crime labs.
- Received industry recognition when elected as a Voting Member of the National Shooting Sports Foundation (NSSF).
- Created “Steel Safe” training ammunition, the industry’s only low velocity .223/5.56mm frangible training ammunition capable of cycling fully automatic AR-style rifles, while not damaging steel targets. Used by agencies nationwide and required for use at many live fire shoot houses. Also created the “Steel Safe” .308/7.62x51mm frangible round for Sniper Entry Training.
- Work with defense contractors, SWAT/HRT teams, and explosives disposal teams on custom ammunition needs. Also work with law enforcement agency training officers on developing purpose-built munitions and systems.
- Licenses: Type 10 FFL (Manufacturer of Destructive Devices), Special Occupations Tax Stamp, and all Dangerous Weapons Permits available from the State of California, DOJ.

Ten-X Tactical was created in 2010 for the purpose of promoting and selling specialty LE/Mil products and services.
- Inventor of PolyFrang® frangible ammunition and President of PolyFrang, LLC. PolyFrang® projectiles are capable of being fired at rifle targets at mere inches without splashback and without damage to rifle targets, and still surpass the minimum accuracy requirements of the military at 100 yards and beyond. The first bullet released was the 45gr 5.56mm round. Now considered to be the leading technology in frangible ammunition, and selected for use by departments and agencies nationwide. Other calibers include 9mm, .40 S&W, 308 Win and 300 AAC BLK.
