The Conditional Release Program (CONREP) is a program for judicially committed persons found by the courts to be Guilty, but Not Guilty by Reason of Insanity; Incompetent to Stand Trial; Persons that had been committed as Mentally Disordered Sex Offenders under the provisions of PC 6316, (repealed in 1981); Mentally Disordered Offenders, Prison inmates required to receive mental health treatment as a condition of parole; and Civilly committed Mentally Disordered Offenders (MDO) parolees in CONREP who have completed their sentence but remain severely mentally ill.
