**FORENSIC TOXICOLOGY FOR ATTORNEYS 2018**  
***“ALCOHOL, DRUGS, AND HOW TO USE AN EXPERT”***

---

**OBJECTIVE:** This course provides practicing attorneys with an intensive day course of instruction in alcohol and drugs forensic toxicology. The course involves practical review of laboratory testing reports and litigation packages from actual alcohol and drug cases. Drug and alcohol metabolisms and effects on the human system will be explained. The course involves review of forensic urine analysis alcohol and drug tests, blood alcohol results, and breath alcohol results. Widmark calculations, micro-method tests designed to detect blood alcohol levels, will be discussed. Different approaches to drug testing and analytical techniques, including immunoassays, thin layer chromatography, gas chromatography, gas chromatography mass spectrometry, and infrared breath machines, will be discussed. After completing the course, participating attorneys will possess practical knowledge and experience for (a) reviewing scientific data contained in laboratory testing reports and litigation packages, (b) requesting relevant information from laboratories and opposing counsel, and (c) understanding the different analytical instruments and techniques used in the forensic laboratory. The expert witness portion of the course focuses on how to effectively utilize a forensic toxicologist expert witness and prepare cross-examination in the courtroom. Practical alcohol and drug cases will be discussed to supplement theoretical concepts and facilitate classroom learning for the attorney. <http://www.toxlabsonoma.com/attorneyclass.htm>
