## Billing Policies

Payment of the flat fee for independent medical record review is required prior to initiation of the review. The flat fee includes review of records up to 1000 pages. Additional records beyond this amount are billed at 800 dollars

per hour. After submission of the written report any additional correspondence or discussion is billed at 800 dollars per hour.
