CAREER SUMMARY

I am an Educational Consultant and Behavior Specialist with extensive experience in instructional coaching, classroom teaching, special education, behavior assessment and planning, and expert testimony focused on educational needs and best practices. My work centers on identifying barriers in school systems and replacing them with strategies that work—for students, staff, and families. I conduct Functional Behavior Assessments and Independent Educational Evaluations in the area of behavior, develop and implement Behavior Intervention Plans, and support educators through coaching, mentoring, and evaluation improvement. I work directly with general and special education staff on managing difficult behaviors, building multi-tiered systems of support, and ensuring compliance with isolation and restraint laws.

My consulting includes auditing district practices, policies, and procedures to ensure alignment with federal and state law, district policy, and professional standards. I assist districts in refining hiring practices, staff training protocols, and evaluation systems, including support for Human Resources and building administrators navigating plans of improvement and probation. I provide professional development on classroom management, de-escalation, and legal compliance, and offer guidance on placement decisions, misconduct investigations, and documentation standards. I have completed ATIXA training in Title IX and Civil Rights investigations and have experience conducting investigations involving harassment, discrimination, and hostile environments. I also serve as an expert witness in education-related litigation and hearings, working with school districts, teachers, and families to provide objective analysis and testimony.

In addition to my education work, I serve as a child safety advocate through multiple national and local roles: I am the President of the Claire Bear Foundation, a national nonprofit focused on child safety, advocacy, and education; a member of the American Academy of Pediatrics National Collaborative for Safe Infant Sleep Family Advisory Group; a consumer safety representative on the ASTM Committee for infant and child product standards; and a member of the Tacoma-Pierce County Health Department Sudden Unexplained Infant Death Review Team. My work in child safety advocacy is directly aligned with my education practice. In both domains, I focus on protecting children through evidence-based strategies, adherence to policy, and objective analysis of systems and outcomes.
