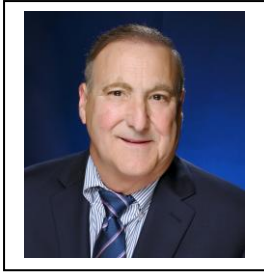

Depositions:

- A. My first deposition was in a civil case that I was being sued personally. I had loaned an Electrical Contracting Company a significant amount of money secured by the three owner's personal California residences. The company defaulted on the note, and I pursued foreclosure of the 3 homes as my remedy. All separate parties sued the Certified Public Accountant (CPA) who had put us together and I was named in an additional suit by the other plaintiffs. All cases were consolidated, and the case was heard in San Francisco Superior Court. I was deposed for approximately 6 hours and was on the stand for approximately 2 hours. I was fully exonerated and received a substantial award from the CPA's Errors and Omissions insurance company.
- B. My second deposition was for a case in which an Electrician was badly shocked by a 12,000 volt utility line, I was deposed in person & on video for 5 hours, case #13.
- C. My Third deposition was for a Commercial Warehouse Building Fire, 15,000 SF 100% loss, Electrician Standard of Care, Zoom Deposition 6 hours, case #29.
- D. My fourth deposition was for a drying furnace that exploded, I was retained to examine the electronic controls, temperature sensors and absence of door locks. Zoom deposition 2 hours, case #41.
