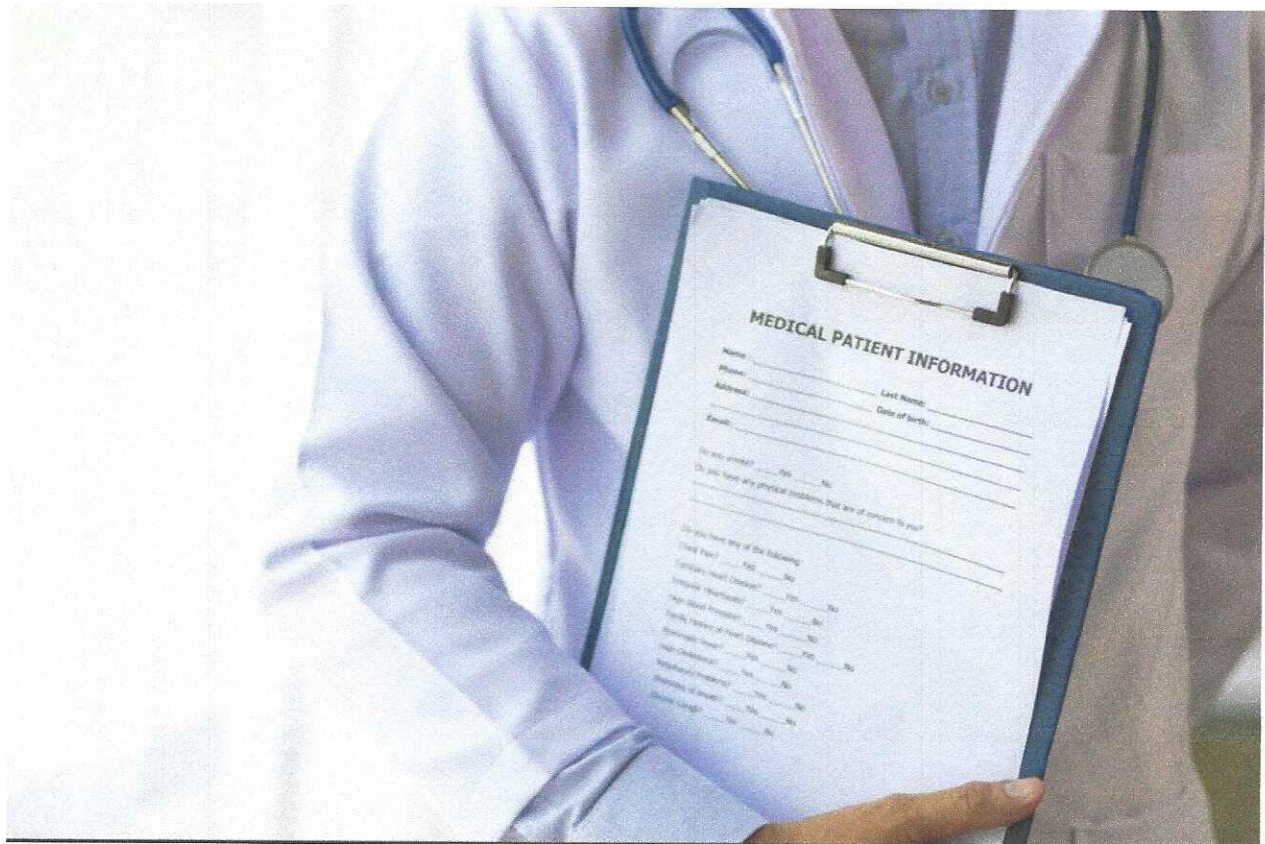

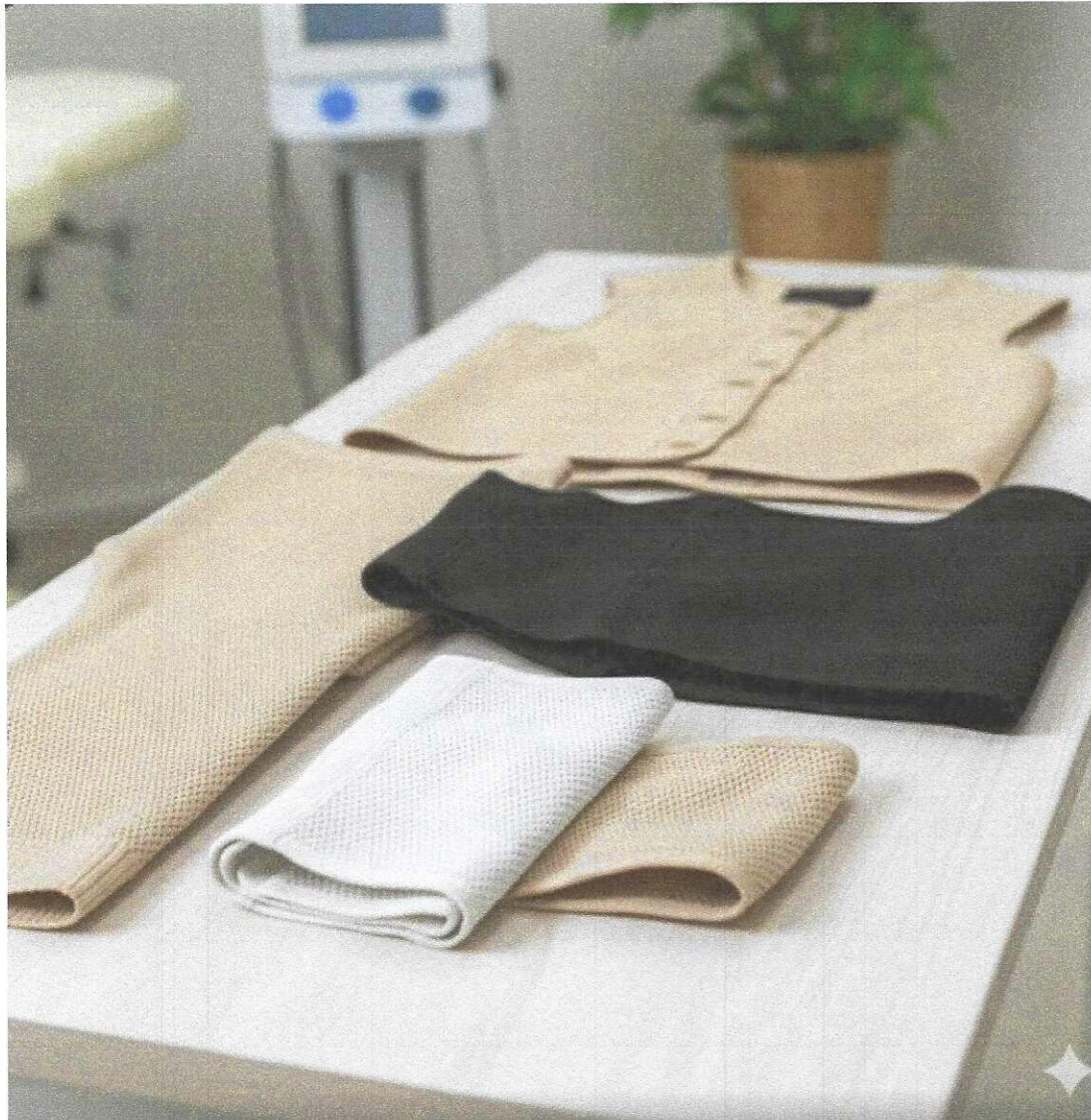

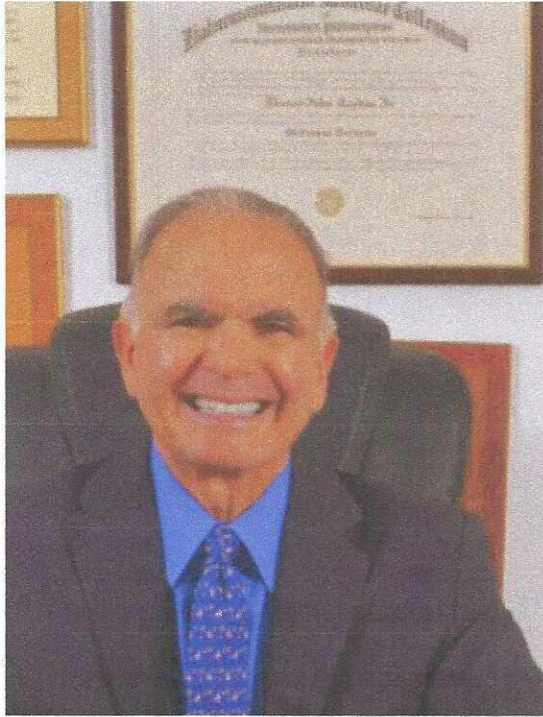
Job Counselling and Job Analysis
